There was one member of the public present who addressed the Council on application 24/00336/FUL - Mr. D Coutts, 49 St Neots Road, Eaton Ford, St Neots. The member of the public was an agent acting on behalf of the applicant and explained the reasons for the proposed work and amendments that had been made to the application since initial refusal by the Local Planning Authority. Part of the reason for refusal was the lack of an arboricultural report, which had now been provided. In addition, the LPA had previously stated concerns over the negative impact on another property, which the agent for the applicant stated they had now accepted was no longer a concern. The agent stated that the proposals had been discussed with the neighbouring property.

The applicant had received feedback on following the initial refusal of planning and stated they had worked to address the points given in feedback.

Members raised several queries, including around access and space for vehicle parking and turning.

The Chairperson moved Members to consider the schedule of plans in front of them.
